The "Affiliate Church/Ministry" agrees to indemnify and hold harmless the AEGA, its officers, representatives, employees, staff, and assigns from all damage, suits, liabilities, or actions intentional or otherwise that may arise as direct or indirect result of the "Affiliate Church/Ministry" meetings or accidents, of whatever kind, or nature, regardless of the proximity to or relationship with the "Affiliate Church/Ministry". The church agrees to hold a current insurance policy that shows (1) general liability coverage and (2) clergy professional coverage.
