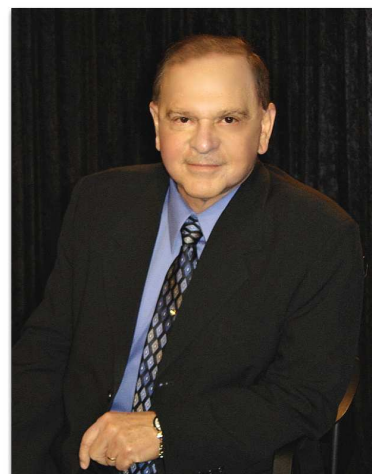

The *Association of Evangelical Gospel Assemblies, Inc. (AEGA)* was originally organized and chartered in 1976 under the name “Christian Ministries” – a local ministerial fellowship in Monroe, Louisiana. In 1988 Godly men with extensive ministerial experience, a fresh vision for soul winning, church planting, missions, and Christian education expanded the Fellowship internationally. Today, AEGA is a respected Association with several divisions (*AEGA Ministries Int’l, Inc.—Paragon Christian Alliance Int’l, Inc. and other outreaches*)– “*imitated by many, but never duplicated!*”



Currently our **Credential and Church-Ministry Division** has members throughout the world, with thousands of men and women of God under its banner. Ministerial credentials are provided for qualified applicants (both men and women). AEGA is an endorser for **Chaplains** (military, prison, & hospital). We also offer the **501(c)(3) tax exempt status under our group exemption** to Churches, Evangelistic Ministries, Counseling Centers, Music & Worship Ministries, Christian Schools and Bible Colleges. As a member of AEGA, you can **fellowship** with those of like precious faith at district and area meetings, and meet believers from around the world at the AEGA World Conference -- held annually at the headquarters in Monroe, Louisiana or in major cities across the United States.



One of the primary missions of AEGA is fulfilled through its **Educational Divisions** – *Omega Bible Institute & Seminary and Evangel Christian University of America* – training hundreds of indigenous ministers *young and old* in the USA and countries around the world. Students from numerous denominations enroll in a *par excellence* study program to earn a bachelor, master, or doctorate degree. Held concurrently with the World Conference, the highlight of the year

is graduation, when students from coast to coast and around the world gather to receive their degrees. When you become a member of AEGA, you become part of the vision to educate laymen and ministers around the globe for the glory of God.

BENEFITS and...

OVERSIGHT: Our leadership is experienced in all areas of ministry. TO APPLY: Complete the enclosed application and MAIL in the postage paid envelope. Or APPLY ONLINE at www.aega.org.

When we receive your application, a complete copy of the **AEGA Constitution & Bylaws** will be mailed to you, along with the scheduled time of your **Telephone Interview** with the **Credential Committee**. A Bible-Knowledge Questionnaire may also be required at the Licensed and Ordained Level. However, the entire process usually takes less than 30 days.

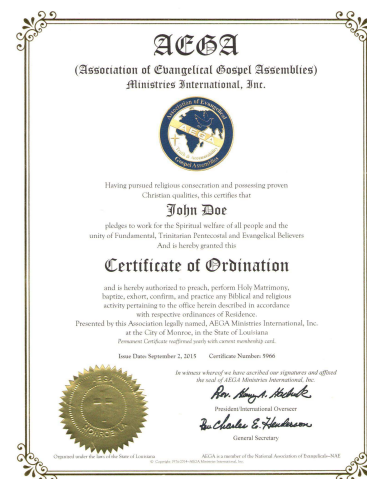


ORDINATION CEREMONY: Your ordination is legally effective upon receipt from AEGA. However, you are encouraged to attend an Ordination Ceremony for the laying on of hands at either the World Conference or any AEGA Area Meeting at any time after receiving your credentials. Foreign Ministers may attend the Conference held annually in their country.

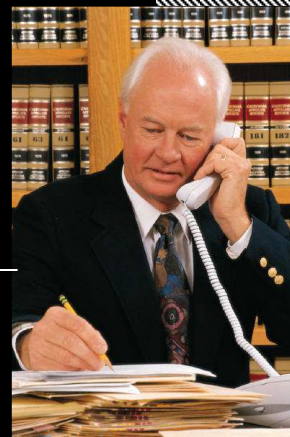

Why Do You Need 501(c)(3) Status for Your Church or Ministry?

Certain events within the past two decades triggered a vast reshaping of public opinion toward local and national ministries, while also prompting the IRS to increase its scrutiny of evangelical churches and ministerial associations. Each year thousands of non-profit, tax-exempt organizations [i.e., 501(c)(3)'s] are audited by the IRS in an effort to ensure compliance to existing IRS Code.

Most beginning ministries concerned with legal and tax issues consult a local attorney and/or CPA. However, they often find these professionals lack adequate knowledge of IRS non-profit regulations and procedures. Ministries everywhere now realize that ***chartering a ministry is a specialized field.***

One of AEGA's *most* significant functions is helping our members to PROPERLY CHARTER their ministries. Having been granted dual Group Exemptions by the Internal Revenue Service, AEGA can provide the 501(c)(3) Exemption for both its church and non-church entities.

Many churches and ministries operate under a state incorporation; however, **this alone does not provide IRS tax-exempt status because there is a difference between “non-profit” and “tax-exempt.”** After obtaining your state incorporation, you must also apply for Exemption from Federal Income Tax under Section 501(c)(3) of the IRS Code. This procedure is often expensive and can take several years obtain. **That's why coming under our Group Exempt umbrella is such a great benefit!**

Charter specialists at the AEGA Headquarters will prepare the documents to qualify your church or ministry for the 501(c)(3) non-profit tax exempt status. What we can do for you in thirty to forty-five days could easily take you one to three years if you act alone.

Remember ... it is imperative that these legal documents be properly prepared ***before*** you receive financial or in-kind contributions. ***Do not jeopardize your ministry and reputation in the community ... permit us to charter your church or ministry the right way.***

AEGA Offers 501 (c) (3) Status under our Group Exemption to the Following Organizations...



LOCAL CHURCH (Existing Churches or New Churches): This Charter protects the church and helps eliminate conflicts that may arise from the community, the state, and the IRS. The Internal Revenue Service definition of a “church” includes a distinct legal existence, a recognized creed and form of worship, and a formal code of doctrine and discipline, in addition to other requirements. *Are you a “church” by IRS definition?* If you’re not sure, call us!

LOCAL MISSIONS: The local mission is similar to the local church, but different in purpose. Like a church, a local mission must have regular services and may begin in a home or other building. Ministering primarily to the poor, orphans, street people, and abused women and children, a mission may offer rooms for rent, distribute food and clothing, and conduct educational or Bible studies. Because a local mission is a non-profit, tax-exempt organization, it is allowed to charge a *reasonable* fee for its services. However, it cannot enforce payment if a person is unable to pay.

EVANGELISTIC ASSOCIATION: This charter is granted (though not limited) to itinerant ministries such as evangelists, missionaries, Bible teachers, and worship leaders. Having an evangelistic charter allows a ministry to receive contributions while traveling anywhere in the US. If tapes, books, or other items are either sold or distributed without charge, this information must be stated in the charter application.

EDUCATIONAL (Church School, Academy, Bible College, Seminary):

Any institution applying for this Charter must clearly outline its purpose and curriculum. Such entities may not be racially discriminatory and must state this fact in the by-laws of the organization. This policy must also be included in its brochures, all catalogs dealing with student admissions, and any other programs and scholarships.

CHRISTIAN COUNSELING CENTER: A Christian counseling center may be part of an established church, or operated independently from the church. It is important to charter and legally establish this type of entity, since state officials closely scrutinize such organizations, often prompted by their competition with local licensed professionals in the fields of psychology and counseling.

A Christian Counseling Center is considered by the IRS to be a religious and charitable organization; and thus may charge a reasonable fee for services rendered. Some centers use a sliding scale fee system. However, the counseling center, like other non-profit organizations, cannot require payment from a client unable to pay. And doing so may result in the loss of the organization’s tax exempt status. (*Counselors may be required by their respective state of residence to maintain a license and carry professional liability insurance*).

Your Certificate of Charter

- ▶ A necessary pre-requisite—the primary pastor of a church or president of a ministry seeking the 501(c)(3) must hold ministerial credentials with AEGA before his/her charter may be processed. Ordained minister is the only level approved for a charter.
- ▶ Once credential is issued, we immediately begin the 501(c)(3) process. The charter forms are mailed to you to complete. Upon receipt at our offices, you should expect to receive your charter within thirty days, provided all requirements are met.

Why does my church or ministry need a 501(c)(3)?

Any organization receiving financial or in-kind contributions without the legal benefit of a 501(c)(3) risks having such funds designated as ‘taxable income’ if audited. Unfortunately, contributors to the ministry would also be deemed liable for back taxes. *The burden of proof is upon the contributor if the church or ministry does not have an official ruling.*

Are there other reasons for obtaining a 501(c)(3)?

Yes, the 501(c)(3) is a necessary pre-requisite when applying for government or public grants. It assures potential donors of the deductibility of their contributions, and provides exemption (in most states) from sales taxes. It assures exemption from Federal excise taxes, and assures non-profit (discounted) mailing privileges.

Questions & Answers

Q: What is a Charter?

A: A charter is an official certificate issued to a church or ministry upon approval by AEGA. Imprinted with the AEGA Group Exemption Number, this document grants to a “subordinate” the 501(c)(3) exempt status and assures that the recipient has met IRS criteria and is under general (not specific) supervision of the AEGA.

Q: Is it really necessary to have a charter?

A: Any church or ministry organization soliciting donations is a prime target if audited by the IRS. If it is determined that you have not legally acquired tax exempt status, your organization may be deemed liable for back taxes and reclassified as a for-profit business. Sadly, your contributors would also be charged for back taxes because of your organization’s failure to obtain a charter recognized by the IRS.

Q: Aren’t Churches Already Considered A 501(c)(3) by the IRS?

A: Yes and No. Churches and their integrated auxiliaries [per Section 508(c)(1)(A) of the Internal Revenue Code] are automatically considered a 501(c)(3)]. This *however* relieves only churches from obtaining a favorable determination letter of their status from the IRS. It **does not relieve a church**

of meeting ALL the requirements of section 501(c)(3). Thus, if audited, the burden of proof is passed to the contributors who must establish that the church does, in fact, meet the requirements of the 501(c)(3).

The courts consider tax-exempt status for churches as an act of “legislative grace.” This places churches under a higher potential for tax inquiry or audit because they have not gone through the legislative process required to receive an official tax-exempt status approval. *We feel it is the responsibility of church leaders to ensure the church is properly set in order, thus relieving any undue burden upon the people who trust their leadership.*

NOTE: Any **religious organization** (non-church) whose gross receipts do NOT exceed \$5,000 in a taxable year are not required to file for the exemption. Those grossing more than \$5,000 per year **are required** to file for their 501(c)(3) status directly from the IRS or come under a group exemption like the AEGA offers. **HOWEVER,** the 501(c)(3) is a necessary pre-requisite all non-profits (including churches) when applying for government or public grants, assuring potential donors of the deductibility of their contributions and providing exemption (in some states) from sales taxes. It also assures exemption from Federal excise taxes and affords the holder non-profit (discounted) mailing privileges.

Q: Is there a cost for a charter?

A: Yes. Currently our fees consist of a one-time \$700 set up charge, and a required monthly general fund offering to AEGA Ministries International. The monthly fee varies according to your annual gross income and whether you are a church or ministry. Charters grossing \$35,000 a year or less are required to give \$35.00 per month, increasing slightly as the ministry grows. The charter is automatically renewed, at no charge, on March 28th of each year provided the ministry remains in good standing with the AEGA.

Q: How do I obtain a charter?

A: Simply complete the forms enclosed in this folder. When your completed forms arrive in our office, we will begin work on them (usually that same day). After your paperwork has been processed, it is evaluated by our charter board. Upon approval, your ministry charter (beautiful certificate suitable for framing and official determination letter) will be issued to you.

Q: How long does it take to acquire a charter?

A: Assuming your paperwork is complete and in order, it normally takes approximately thirty (30) days or less from the date your charter application is received. (*Note: No charter application can be processed until your Application For Ministerial Credentials at the Ordained level has FIRST been approved.*)

Q: Am I required to file ministry reports with AEGA?

A: Yes. A financial summary report is due at the end of each year. This is required by the Internal Revenue Service, and is for your benefit and protection. However, AEGA does not manage your funds or tell you how to operate you ministry. Each ministry is autonomous and sovereign.



Q: Must I become a member of AEGA to receive a charter?

A: Yes. If you are the president of the ministry, you are required to hold credentials with AEGA at the Ordained level. This policy is primarily for accountability & liability purposes, thereby providing benefits for the credentialed minister as well.

Q: Why is there a Monthly Giving Requirement?

A: As a true fellowship, we are supported entirely by our member ministers, churches, and ministries just as the local church is supported by those it serves and oversees. And as the Apostle Paul submitted himself to the leadership in Jerusalem and received offerings for distribution to those in need, we also work with our member ministries and churches to build and advance the Kingdom of God around the world (2 Corinthians 8:1-9, 9:6,7). (see more about this under "Structure" on page 4)

Q: Must I have a Board of Directors?

A: Yes. The IRS requires that all chartered ministries have a Board of Directors. Although each ministry is autonomous and sovereign, a minimum of 5 board members is required before approval can be granted. Only two of these 5 members may be blood relation; and the president and treasurer must not be related by either blood *or* marriage. *(A ministry may begin with three board members, adding two more within the first year. The first three are required to be President, Secretary and Treasurer).*

Q: My church or ministry does not have Bylaws. Aren't these required?

A: Yes. By-Laws are required before your organization can be chartered or incorporated; therefore they are a pre-requisite to the 501(c)(3). But once again, AEGA makes it easy. We will prepare your By-Laws for the low cost of \$50.00

Q: My Church or ministry is NOT incorporated. Isn't this necessary prior to obtaining the 501(c)(3)?

A: Yes. Incorporation is required, as this signifies legal status with your state. You must provide a copy of your state incorporation for our review. This is to ensure compliance with specific wording in the IRS code, and is required prior to granting the 501(c)(3). If your Articles of Incorporation do not meet requirements, we will do what is necessary to make them compliant for a fee of \$50.00.

Q: Is the AEGA Office available if I have IRS or accounting questions?

A: Yes! Our Church Tax/Law Specialists and CPA are always ready to consult with you at *no charge*. And most importantly, we are here to lift you and your ministry up in prayer. This is truly a great benefit of being part of an international fellowship... you are not alone!

Q: What should I do first to begin the process?

A: Complete the enclosed Application for Ministerial Credentials and the Charter Request Form and mail them to AEGA. Or you can go to www.aega.org and complete online. Send no money at this time. You must choose "Ordained Minister".

Q: Can I lose My 501(c)(3) Charter?

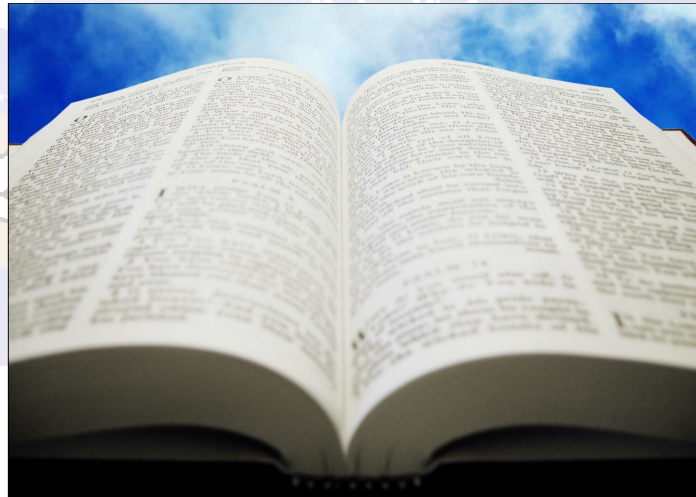
A: Yes, under the following conditions: (1) You may voluntarily withdraw your charter at anytime. (2) Should your ministry or church fail to comply with the requirements set forth in the By-Laws, your Charter can be revoked. (3) Should the membership of the Pastor or Ministry Director lapse or be revoked by AEGA, the Charter is automatically forfeited.

Q: What if I already have the 501(c)(3)? How can I be part of AEGA?

A: You can use our "AFFILIATION PROGRAM." This program is for people who desire fellowship, but have already obtained the 501(c)(3) exemption directly from the IRS. You may be a credentialed member of AEGA or may be credentialed with another recognized organization with same doctrinal beliefs. There is small fee to process the affiliation of your church or ministry with AEGA. We do request that you prayerfully and financially support the fellowship. To affiliate with AEGA, call our office and request an "Affiliation Form" or go to www.aega.org to apply online.

Our Eighteen Fundamental Truths

We, the members of the General Executive Presbytery Board of the Association of Evangelical Gospel Assemblies, have taken in hand to set forth a declaration of Eighteen Fundamental truths most surely believed among us as necessary in understanding the intent of the Living God. We pray that there be no harmful differences which lead to disunity, divisiveness, or disharmony among the brethren, the Churches, or Association, and that we may be all of the same mind and judgment, speaking the same things in love (Acts 2:42; I Cor.1:10).

THE BIBLE—OUR SOLE GUIDE

The Bible is our sole guide and sets forth criteria for a heaven-bound people. We believe that it supremely declares the “Holy Oracles” of God which our confidence in its profound truth is essential for establishing our faith and religious practices.

1 - The Scriptures

The Scriptures, both the Old and New Testaments, are verbally inspired, the product of holy men of old who spoke and wrote as they were moved by the Holy Spirit (2 Pet. 1:21). The Bible is the revelation of God to mankind, the inerrant, authoritative guide for faith and conduct (2 Tim. 3:15-17; I Thess.2:13)

2 - The Triune Godhead

The one true God has revealed Himself as the eternal, self-existent, immutable, “I Am,” the Creator of the universe and the Redeemer of mankind (Deut. 6:4; Ex. 3:14; Isa.43:10,11). God has further revealed Himself as a Triune Being but manifested in three personalities as Father, Son, and Holy Spirit (Isa.48:16; Matt. 28:19; Luke 3:22). God the Father is greater than all (John 14:28), the Source and Begetter of the Word (John 1:14; 16:28). *No man hath seen God at any time, the only begotten Son, which is in the bosom of the Father, He hath declared Him* (John 1:18). The Son is the Word, God incarnate, the One begotten, and existed with the Father from the beginning (John 1:1, 14, 18), being co-equal with God (Phil. 2:6). The Holy Spirit proceeds forth from God the Father (John 14:26; 15:26) and God the Son (John 16:7) and is eternal (John 14:16), being promised by Christ from the Father to all cleansed believers (John 14:16, 17).

(a) The Holy Trinity - The term “Trinity,” while not found in the Scriptures, is a term that conforms to the Scriptures. The New Testament teachings of Christ express a relationship of Father, Son, and Holy Spirit, and yet the “Trinity” is incomprehensible and inexplicable (Luke 1:35; I Cor.1:24; Matt. 11:25-27; 28:19; 2Cor.13:14; I John 1:3, 4).

(b) The Holy Trinity does not operate in modes as taught by oneness Pentecostals. Although God is One in His Unity and Essence (Deut. 6:4) there are three distinct persons, each of whom is in full possession of the divine essence (Mt. 28:19; II Cor.13:14). The proper terminology for the Godhead is: God the Father; God the Son; and God the Holy Spirit.

3 - The Deity of the Lord Jesus Christ

The Lord Jesus Christ is the eternal Son of God, is divine, and shares in the Deity of God as the second person in the Holy Trinity (Matt. 1:23; John 5:22,23; 2 John 3; Heb. 1:1-3).

4 - Original Sin and the Fall of Man

Man is a created being, made in the likeness and image of God; for God said, *Let us make man in our image, after our likeness* (Gen. 1:26, 27). However, the first man, Adam, by his transgression fell, and thus sin entered into the world resulting in physical and spiritual death, which is separation from God (Gen. 1:26,27; 2:17; 3:6-24; Rom. 5:12-19). *For all have sinned, and come short of the glory of God* (Rom. 3:23). *As it is written there is none righteous, no not one* (Rom. 3; 10).

5 - The Salvation of Man

The only hope of redemption for humankind is through the shed blood of Christ, the Son of God (Luke 24:47). Salvation is received through repentance (i.e., a change of heart, attitude, mind towards God) and faith in the Lord Jesus Christ (Acts 4:12; Rom. 5:8-13; 10:9; Jas. 1:21; Eph. 2:8). The Spirit bears witness inwardly that we are saved (Rom. 8:16), while there is definite evidence outwardly of a consecrated life of righteousness and holiness (Eph. 4:24; Titus 2:12). We believe that eternal life in Heaven is the reward of the righteous (Matt. 24:13; Mark 13:13).

6 - The Church

The true Church is the Body of Christ (I Cor.12:12-27), not intended to be the edifice or institution, but the habitation of God through the Holy Spirit. Each believer, born of the Spirit, is an integral part of the General Assembly and the Church of the firstborn which was written in Heaven (Eph. 1:22, 23; 2:22; Heb. 12:23).

7 - The Mission of the Church

Since God's purpose concerning mankind is to seek and save that which is lost (Luke 19:10), to be worshiped by all mankind and to build a body of believers in the image of His Son, the mission of the Church is:

- (a) To be an agency (i.e., The Universal Church) for evangelizing the world (Acts 1:8; Matt. 28:19, 20; Mark 16:15,16).
- (b) To be a corporate body (i.e. The Local Church) in which man may worship God (I Cor.12:13).
- (c) To be a channel (i.e., The Universal and Local Church) of God's purpose to build a body of saints being perfected in the image of His Son (Eph. 4:11-16; I Cor.12:28; 14:12;).

8 - The Ordinances of the Church

(a) Baptism in water

The ordinance of baptism by immersion in water is commanded in the Scriptures. All who repent of their sins and believe in Christ as Savior and Lord are to be baptized (Matt. 28:19; Mark 16:16). Baptism is a declaration of a good conscience towards God, a symbol of the believer's identification with Christ in His death, burial, and resurrection (Acts 2:41; 10:47, 48; Rom. 6:4,5). We officially recognize the baptismal formula listed in Matthew 28:19 and recommend the following procedure for baptizing converts: "On the confession of your faith in the Lord Jesus Christ, the Son of God, and by His authority, I now baptize you in the name of the Father, and of the Son, and of the Holy Ghost (Spirit).

(b) Holy Communion (the Lord's Supper)

The Lord's Supper, consisting of the elements - bread and the cup of the fruit of the vine - is a symbol that typifies our sharing in the suffering, resurrection and exaltation of our Lord and Savior, Jesus Christ (2 Pet. 1:4); a memorial of His sufferings and death (I Cor. 11:26; Phil. 3:10); a reminder of His second coming (I Cor.11:26), and is enjoined on all believers "till He comes!"

9 - The Baptism in the Holy Spirit

Every believer is entitled to, should seek for, and should expect to receive the “Baptism in the Holy Spirit” (KJV “Holy Ghost”). This experience, which is an endowment of power for Christian service was active and necessary in the early Apostolic Church for the fulfillment of the ministry of the Apostles (Luke 24:29; Acts 1:4,8; I Cor.12:1-31). We believe the “Spirit Baptism” is distinct from and subsequent to the experience of the “new birth” (Acts 8:12-17; 10:44-46; 11:14-16; 15: 7-9). There are definite signs that accompany this experience such as overflowing fullness of the Spirit (John 7:37-39; Acts 4:8), evidence of the fruit of the Spirit (Gal. 5:22, 23), a deepened reverence for God (Acts 2:43; Heb. 12:28), intensified consecration and dedication to work for God (Acts 2:42), an ever-abounding love for the Word of God, love for Christ, and a burning desire to see lost mankind saved (Mark 16:20).

10 - The Initial Evidence of the Baptism in the Holy Spirit

The Baptism of all born-again believers “in the Holy Spirit” is always witnessed by the physical initial evidence of speaking with other tongues as the Spirit of God gives them utterance (Acts 2:4). Speaking in tongues in this instance (Acts 2:4) is the same in essence as the “gift of tongues” (I Cor.12:4-10, 28), but different in purpose and use. These tongues are not learned but are a mystery, a gift, as the speaker is prompted by the Holy Spirit (I Cor.14:2).

11 - Divine Healing

Divine healing was clearly provided for in the Old Testament (Ex. 15:23-26; Ps. 103:1-3; Isa.53:4,5) and is an integral part of the New Testament Gospel as taught by Christ, the Apostles, and the early Church (Matt. 8:16,17; Acts 5:16; Jas. 5:14-16). Deliverance from physical and mental diseases, sicknesses, or ailments is provided for in the Atonement (Matt. 8:16, 17; Jas. 5:14-16). Divine healing is wrought by the power of God through the prayer of faith, the laying on of hands (Mark 16:18; Jas. 5:14, 15), fervent prayer (Jas. 5:16), and is the privilege of every believer who will accept it (Luke 5:15).

12 - Sanctification

Sanctification is a definite yet progressive work of grace, as taught in the Scriptures, which leads to holiness (Rom. 6:22). Christians should lead a life of holiness, *Follow peace with all men, and holiness without which no man shall see the Lord* (Heb. 12:14). Sanctification in the believer is demonstrated by an act of separation from anything considered sinful in the Scriptures and of dedication to God (I Thess.5:23; 2 Pet. 3:18; Phil. 3:12-14; I Cor.1:30). The believer is enabled by the power of the Holy Spirit to obey the command of holiness, *Be ye holy, for I am holy* (1 Pet. 1:16). The believer continues in holiness because of who he is in Christ, realizing that his identification with Him (Christ) in His death and resurrection by faith necessitates every faculty be controlled by the Holy Spirit (Rom. 6:1-11,13; 8:1,2,13; Gal. 2:20; Phil. 2:12,13; 1 Pet. 1:5).

13 - The God Appointed Ministry

God by the Holy Spirit definitely calls whom He desires (wills) to serve in the five-fold ministry (Eph. 4:11), and qualifies the ones called with power, talents, wisdom, and gifts pertaining to that office or offices (I Cor.12:28). *Let every man abide in the same calling wherein he was called* (I Cor.7:20).

Ordained Ministers and Deacons

All ministers are divinely called and commissioned to preach the Gospel and evangelize the world (Mark 16:15-20), to worship God (John 4:23, 24), and build up the body of saints being perfected in the image of His Son (Eph. 4:11-16).

(a) Women Ministers

When called of God and anointed by the Holy Spirit, women shall have the freedom to serve in the ministry as they are led by the Spirit (Joel 2:28, 29; Acts 2:18; 8:17,18).

(b) Divorce and Re-marriage

When a divorce and re-marriage has taken place, the matter shall be left strictly to the individuals concerned and their conscience (Acts 11:9; 1 John 1:7; 2:1,2; Heb. 4:14-16; Matt. 12:31; Ps. 103:11,12). Candidates desiring credentials are examined by a committee on a one-to-one basis with all extenuating circumstances in their pasts carefully considered.

(c) Definition of Marriage & AEGA's Stance on Homosexuality:

►We resolve that as a matter of belief, doctrine, and religious practice, AEGA Fellowship reserves the term “**marriage**” for the covenant relationship between (naturally born) one man and one woman to the exclusion of all others, which has always been our belief. **Member Participation in the Solemnization and Celebration of Marriage:** We resolve that members of AEGA Fellowship, both laity and clergy, will be allowed to arrange for, officiate at, or take part in the solemnization or celebration of a marriage *only* when it conforms to AEGA Fellowship's statements regarding marriage. We believe the Bible teaches that marriage is intended by God to be a life-long covenant of fidelity between a man and a woman symbolizing the relationship of Christ and His Church. This biblical and traditional understanding of marriage is the basis of strong, healthy families; and is therefore to be nourished and defended by the local church and all members of this Fellowship. Our members are not to participate in cultivating union or legal marriage at any time of those of the same sex. For our military chaplains this would include forbidding them to provide, perform, or participate in sessions such as but not limited to “Strong Bonds Training Sessions” that include same sex couples. To do so would result in the removal of their ministerial credential and their endorsement by this fellowship.

►While AEGA Ministries is fully convinced according to Scripture (see references below) that God is opposed to homosexuality and the gay lifestyle, we also understand that He seeks to forgive and restore all who come to Him. It is our belief that homosexuals are sinners like everyone and need God's forgiveness. We believe they can be set free from the power of this sin and live a changed lifestyle. We believe we are to love the person caught in this deception but as the church we are called to make a stand against the unrighteousness of this practice.

Homosexuality comes against God's divine plan for the human race in that homosexual couples cannot procreate as commanded in Genesis. It not only perverts the order of marriage established in the Garden of Eden but also brings the possibility of disease in the body and distress in a person's emotions and spirit.

It is for the reasons listed above and the foundation of the scriptures listed below, that we forbid our members to perform, sanction, bless, or attend any type of marriage, cohabitation, or covenant ceremony of persons of the same sex. To do so will result in the dismissal of said member's credential.

Genesis 19, Leviticus 18:22, Romans 1:26, 27, and I Corinthians 6:9-10

(d) Ordained Deacons

Every church has as its right and duty to choose, appoint, and ordain deacons as helpers, administrators, teachers, and workers. The office of “deacon” shall constitute a position of honor and respect, both from the pastor and the congregational body of believers. The word for “deacon” is from the Greek word “*diaconos*,” a “servant,” especially one who waits on tables. We recommend that the church select those full of the Holy Ghost (Spirit), God-called and anointed, having a desire to serve the Lord and His people (Acts 2:4; I Cor.12:4-10, 28).

(e) Qualifications for Deacons

The qualifications for deacons should be observed as binding when selecting a candidate for deacon ordination (see Tim. 3:8-13).

14 - Tithing

We believe that all Christians (including ministers) should tithe to the storehouse (Mal. 3:10,11). *Will a man rob God? Yet ye have robbed me, but ye say, wherein have we robbed thee? In tithes and offerings* (Mal. 3:8). Church members should tithe to the local church where they receive their spiritual food. Credentialed members of the Association of Evangelical Gospel Assemblies (AEGA) should recognize that tithing supports the local church and the universal church (*see Eighteen Fundamental Truths #7 "The Mission of the Local Church"; see Constitutional By-laws Article II "Loyalty and Dedication"*).

15 - The Blessed Hope

We believe in the Pre-millennial coming of our Lord in the clouds to catch away His Bride. The angel said, *This same Jesus shall so come in like manner* (Acts 1:11). The resurrection of those who have fallen asleep (died) in Christ is "the blessed hope" of the Church: *The dead in Christ shall rise first; then we which are alive and remain shall be caught up together with them in the clouds to meet the Lord in the air* (1Thess.4:16,17; also Rom. 8:23; I Cor.15:51,52; Titus 2:13).

16- The Second Advent of Christ

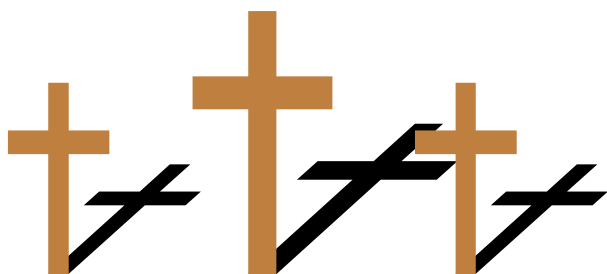
The second coming; the visible return of Christ with His saints to reign with Him on earth for one thousand years (Zech. 14:5; Matt. 24:27, 30; Rev. 1:7; 19:11-14; 20:1-6). This Millennial reign will bring salvation to national Israel (Ezek. 37:21, 22; Zeph.3:19, 20; Rom. 11:26, 27) and the establishment of universal peace (Isa.11:6-9; Ps. 72:3-8; Mic.4:3, 4).

17 - The Final Judgment

There will be a final judgment in which the wicked dead will be raised and judged according to their works. Whosoever is not found written in the Book of Life, together with the devil and his angels, the beast and the false prophet, will be consigned to everlasting punishment in the lake which burns with fire and brimstone, which is the second death (Matt. 25:46; Mark 9:43-48; Rev. 19:20; 20:11-15; 21:8).

18 - The New Heavens and the New Earth

We, according to His promise, look for new heavens and a new earth wherein dwelleth righteousness (2 Pet. 3:13; Rev. 21:1).

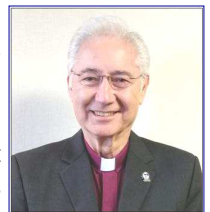

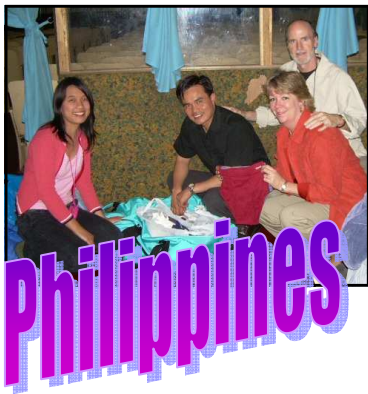


